Great Arthur House Update

Pre-construction work is ongoing.

Keepmoat and Fill Metallbau (the cladding specialist) completed the heritage mock-up (of wall and window). This was installed alongside the Northern end of Great Arthur House in November and removed in December. The City Planners, English Heritage and 20 Century Society had the opportunity to view the final design.

We are awaiting approval of the design, materials and mock up, it is hoped that a decision will be made by mid-February 2015. The works should then start on site in April and complete 12 months after commencing.
